WHAT DOES Mountain West Financial LLC DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none">■ Social Security number and income■ Assets and Credit score■ Account Balances and Payment history		
How?	All financial companies need to share customers personal information to run their everyday business. What we do

How does Mountain West Financial LLC protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Access is limited to authorized employees, and service providers are required to safeguard your information.

How does Mountain West Financial LLC collect my personal information?

We collect your personal information, for example, when you

- Apply for a loan or provide account information
- Provide employment info or show your drivers license
- Give us your contact information

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates may also include other companies under common ownership or control, whether now existing or formed in the future.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *MOUNTAIN WEST FINANCIAL, LLC. does not share with nonaffiliates so they can market you*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partners may include other companies that provide financial products or services.*
